**STATISTICAL INDICATORS RELATED TO
TARIFF LINES BOUND AT LOW RATES**

Note by the Secretariat¹

I. INTRODUCTION

1. Following a request from Negotiating Group on Market Access concerning the issue of tariff lines bound at low rates, the Secretariat did some analysis on the tariff profiles and related import flows with particular emphasis on low duties. The data were taken from the Consolidated Tariff Schedules (CTS) database and the Integrated Data Base (IDB).² The product coverage is limited to non-agricultural products, i.e. all products not included in the WTO Agreement on Agriculture.

II. FREQUENCY DISTRIBUTION OF BOUND DUTIES AND CORRESPONDING IMPORT FLOWS

2. A frequency distribution of *ad valorem* bound duties at the tariff line level as they appear in the CTS is shown in Table 1. The class intervals for the duty rates were set to one per cent intervals up to five per cent with duty free lines in a separate class interval. Bound duties higher than five per cent and non *ad valorem* duties are also presented to give a complete profile of the bound duties for each Member. The table shows the number of bound tariff lines for each class interval for each Member's schedule and the corresponding percentage based on all bound tariff lines.

3. For Members for which IDB/CTS linked files have already been established the corresponding import flow for each class interval of bound duty are presented in Table 2. Only Members with available import data and with non zero duties at or below 5 percent are retained in this table. The import value corresponding to unbound tariff lines was calculated as the difference between total imports of non-agriculture products and imports for bound tariff lines only. The percentage share was based on total NAMA imports.
